ISOC-CH Board:

29 March 2017: Annual General Assembly held in Bern, election resulted in a new Board.

Throughout 2017-2018, the ISOC-CH Board met in person and via google hangout on a regular basis.

In 2017, Richard Hill, Vice-Chair for External Affairs, was re-elected to the Chapters Advisory Council of Internet Society.

2017-2018 Board and Member Activities:

30 May 2017: Swiss IGF participation / ISOC-CH's Head of Public Policy Bernie Höneisen moderated a session and several ISOC-CH Board members attended the discussions

23 June 2017: ISOC-CH was awarded a Beyond the Net grant of 30,000 USD to work on the project entitled **Implementing Privacy via Mass Encryption: Standardizing pretty Easy privacy's protocols**. This two-year long project (June 2017-June 2019) will be undertaken together with the pEp Foundation in order to implement privacy by design. More specifically, the project aims to standardise pretty Easy Privacy protocols and help encrypt end-to-end all communication via close involvement in the work of the Internet Engineering Task Force. In the framework of the project, ISOC-CH participated in three IETF meetings (in 2017: IETF 99 in Prague; IETF 100 in Singapore; in 2018: IETF 101 in London)

Starting in September 2017, ISOC-CH supported the referendum against Internet blocking by collecting signatures in close cooperation with Digitale Gessellschaft and the Pirate Party, continuing our fight for an open internet. <u>https://www.isoc.ch/archives/2908</u> and <u>https://www.isoc.ch/archives/3003</u>

19 September 2017: ISOC-CH co-hosted, together with ISOC, a special 25th anniversary event for Internet Society at CERN in Geneva as part of the 2017 InterCommunity. The event included a panel focused on national matters and in particular the discussion on network blocking, as well as an international panel with the participation of 3 Internet Hall of Fame inductees and Roxana Radu, ISOC-CH Chair. https://www.isoc.ch/archives/2892

ISOC-CH's engagement with Swiss politics

Several members of ISOC-CH have been actively engaged with the legislation process by bringing the topics of most relevance to the free and open Internet to the attention of government agencies and members of the Swiss Parliament.

The most important topic in the past year has been network blocking provisions as introduced by the new gambling law for the first time. However, draft proposals of the new Telecommunications and Copyright Acts contain network blocking provisions.

ISOC-CH's Head of Public Policy Bernie Höneisen as well as ISOC member Simon Schlauri attended a parliamentary Hearing regarding the new Telecommunications law. Bernie focused on network blocking suggesting "Removal of illegal content as opposed to network blocking" as successfully applied in other countries (e.g. Germany, Austria and others). Simon suggested to include further provisions to ensure Net Neutrality cannot be violated by Providers.

Several ISOC-CH members such as Jorgo Ananiadis, Simon Gantenbein and Marcel Waldvogel - among others - supported this work, which is a joint effort together with Digitale Gesellschaft and the Swiss Pirates' party.

ISOC-CH Committee Activities:

1) Public Policy Aspects Committee (PPAC) is a committee of ISOC-CH according to the statutes (§ 30) and aims to discuss and propose actions to the Board on matters related to public policy. We had a

- Technical Aspects Committee (TAC) is a committee of ISOC-CH (in formation) according to thestatutes (§ 30) and aims to discuss and propose actions to the Board on matters related to technology. Not active in 2017.
- 3) Social Aspects Committee hosted events in Geneva (11 September 2017, 12 January 2018) and Zurich (22 June 2017) to meet with members and discuss topics of interest.
